Why we developed a new offer

- Increasing focus on academic governance and assurance from regulators and political interest in issues surrounding higher education
- Provide assurance to governing body that academic governance is effective governance is effective
 - In England it is now a regulatory requirement to ensure effective student outcomes as part of Ongoing Condition of Registration – B3, including student continuation and graduate employment metrics
 - In Scotland, it is now a requirement, from SFC, to undertake an external academic governance review (bicameral review)
- Support institutions in **undertaking further review work** chance to understand own perception of performance anonymously
- Opportunity to understand where institutions compare across the sector

 similar to Advance HE's Corporate Governance Effectiveness Benchmark Survey



- 8 themes which are benchmarked
 - Commitment to effective governance
 - Academic governance and assurance
 - Structure and processes
 - Recruitment and membership
 - EDI
 - Working relationships and behaviours
 - Outcomes of effective governance
 - The Committees
- Optional extra sections per institution not-benchmarked
- **7 point scale** "strongly agree-strongly disagree" with option for "don't know"
- Roughly 20 minutes to complete

Comparison across sections (All respondents)

This chart shows how each Section has scored (by averaging the Agree scores (Strongly Agree to Partially agree) for all questions in each section). Using a RAG system, Sections scoring above 80% are in green, Sections scoring 70% to 79% are in amber and Sections scoring 69% and under are in red. The same RAG system is used in the following tables for the individual questions (measures).


